Does your cat have high blood pressure?

High blood pressure or hypertension is a common problem in people - did you know it is also very common in older cats?

Hypertension can occur as a primary problem or sometimes in association with other diseases especially kidney disease and hyperthyroidism.

Untreated high blood pressure can cause serious problems in many organs such as the eyes, brain, heart and kidneys. Blood pressure is easily checked using a cuff and ultrasound probe in a similar way to humans. If your cat is suffering from hypertension then it can be treated easily and usually very effectively.

We advise blood pressure checking in older cats with kidney disease or hyperthyroidism and in some cases as part of routine screening.

Pets Travel Scheme - changes for 2012

The Pets Travel Scheme has been operating for over a decade now. It was introduced to allow pet animals to travel to a range of countries and then to re-enter the United Kingdom without having to go into quarantine. To date around 750,000 animals have travelled with around 100,000 travelling each year currently.

From the beginning of 2012 there will no longer be any requirement for animals to be blood tested after their rabies vaccine to be eligible for a passport. Instead we will be able to issue a passport once a period of three weeks from the date of the rabies vaccine has elapsed.

Additionally there will no longer be any mandatory requirement for tick treatment prior to re-entering the UK. We still strongly advise stringent preventative tick treatment for all animals travelling abroad to reduce the risk of acquiring a number of very serious tick borne infections. Preventative treatment against sandflies may also need to be considered.

Tapeworm treatment will still be required for pet dogs before travelling back into the UK. Not less than 24 hours and not more than 120 hours (1-5 days) before its scheduled arrival time in the UK under the Pet Travel Scheme, your dog must be treated against tapeworm and the treatment recorded in the pet passport.
